The mission of the LEC is to:


- Oversee the architectural standards established by the original developer for the Anthem Country Club community.

Gates, Property, and Patrol Committee Report

In the Works

- Evaluating new electronic speed signage.
- Evaluating Phase 2 of storm water management project.
- Working with staff and Board to resolve asphalt remediation in Candlewyck Community.
- Continuing traffic monitoring and enforcement.
- Worked with staff on new policy for gate repairs and damage.
- Working with staff and Board on new security services contract.



Recommendation

- The committee recommends a fee of \$150 for each gate damage incident in addition to any gate arm replacement costs and fines.
- The committee recommends the acceptance of the new security services contract with Trident Security.
