
- Summer camp registration is open. The tenweek themed program includes a new addon component (sports, dance, or aquatics) for an additional fee.

- Soccer Fields #1-4 recently underwent the aeration process with a heavy sand top dressing. The aeration process changes the composition of the soil to allow for a better transition from rye to bermuda grass.
- Softball Field #1 LED lighting conversion project is complete. This was a lengthy project with research, planning, and preparations that started last summer.
- Little League Fields #1 & #2 underwent the annual resurfacing project by grading and adding turface to the infield. This process improves surface play and ball-handling.

Summary:

 After Reserve Funding and Depreciation, YTD March Financial Results are a surplus of \$112k, less than 2020 by \$133k. Considering the change in Reserve funding in 2021 vs 2020 \$26k, there is <\$107k> less surplus YTD March 2021. YTD March has resulted in \$30k less revenues than budgeted and \$10k more than YTD March 2020.



Balance Sheet Review:

- Operating Cash balance, net of cash balances due to our HOA partners and advances for Master Plan Projects is \$5.9 million. Of this, \$1.7 million is prepaid assessments received.
- Adjusted Reserve Fund balances are at \$17.8 million. The 2021 Budget calls for Reserve contributions totaling \$1.9 million, \$158k per month, against an anticipated spending of \$2.3 million.
- Enhancement Fund balances are \$1.43 million. The Enhancement Fund generated \$100k in March vs. an annual budget of \$965k. Prior Year March was \$108k. YTD March 2021 total is \$281k vs March 2020 \$221k.
- Total Collections and Accounts Receivable balances, as of March 31, 2021 and March 31, 2020 were \$346k, and \$464k respectively, with a reserve of \$328k.



YTD Income Statement Review:

- Before Reserve contributions, YTD March Revenues were \$26k ahead 2020, and <\$1k> behind budget.
- March YTD Operating Costs were \$72k more than 2020. Mostly due to a year-over-year comparison of Insurance premiums, Repairs and Maintenance and Investment gains.
- YTD Operating Surplus was \$356k, less than 2020 by <\$132k> (before depreciation and taxes).
- YTD Net Book Surplus, including Depreciation, is \$112k, behind 2020 by <\$133k>

Reserve surplus \$105k ENH surplus \$242k Total Operating Surplus \$460k (includes unspent reserve and enhancement funds)
